Section 3: HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

DANGER. Harmful or fatal if swallowed. Aspiration hazard. Avoid contact with skin or eyes. Avoid breathing vapors or spray mist. Keep away from heat and flame. Contents under pressure. Do not puncture or incinerate container.

Primary Route of Entry: Skin contact, inhalation

Acute/Potential Health Effects:

EYES: Causes severe irritation, experienced as discomfort or pain, excess blinking and tear production, with redness and swelling of the conjunctiva.

SKIN: Brief contact may cause slight irritation. Prolonged contact may cause more severe irritation with pain and local redness.

INHALATION: High vapor/aerosol concentrations (>1000ppm) are irritating to the respiratory tract.

INGESTION: Harmful or fatal if swallowed. Aspiration hazard - this material can enter lungs during swallowing or vomiting and cause lung inflammation and damage.

Section 4: FIRST AID MEASURES
